ORDINANCE NO. 2192-2020

EXTENDING THE DEADLINE FOR THE PAYMENT OF REAL PROPERTY TAX FROM MARCH 31, 2020 TO JUNE 30, 2020 (FOR 1ST AND 2ND QUARTER), BUSINESS PERMIT FROM APRIL 20, 2020 TO JULY 20, 2020 (FOR 2ND AND 3RD QUARTER) AND TRICYCLE PERMIT FROM MARCH 30, 2020 TO JUNE 30, 2020 WITHOUT PENALTY IN THE CITY OF DAGUPAN.

WHEREAS, this body is in receipt of a letter dated March 16, 2020 from His Honor, Marc Brian C. Lim, City Mayor, requesting this body to pass an ordinance extending the deadline for the payment of real property tax from March 31, 2020 to June 30, 2020 (for 1st and 2nd quarter), business permit from April 20, 2020 to July 20, 2020 (for 2nd and 3rd quarter), and tricycle permit from March 30, 2020 to June 30, 2020 without penalty in the City of Dagupan;

WHEREAS, pursuant to Executive Order No. 22 instituting citywide measures to prevent the transmission of acute respiratory and viral diseases and the potential spread of corona virus 2019 (COVID-19) and to alleviate the worsening impact of these health, safety and economic challenges, it behooves upon this body to extend relief to our burdened taxpayers;

NOW, THEREFORE, on motion of Councilor Maria Librada Fe M. Reyna, duly and jointly seconded by Councilors Cisco Jay P. Flores, Karlos Liberato E. Reyna IV, and Marvin V. FAbia, be it enacted by the Sangguniang Panlungsod in its regular session assembled:

SECTION 1. The payment of the following fees shall be extended on their respective schedule without penalty.

NATURE OF PAYMENT	ACTUAL DEADLINE	EXTENSION
a. Real Property Tax	March 31, 2020 (for 1 st Quarter)	June 30, 2020 (for 1 st & 2 nd Quarter)
b. Business Permit	April 20, 2020 (for 1 st Quarter)	July 20,2020 (for 2 nd & 3 rd Quarter)
c. Tricycle Permit	March 30, 2020	June 30, 2020

SECTION 2. This Ordinance shall take effect upon approval.
