ORDINANCE NO. 2195-2020

GRANTING RENT HOLIDAY TO TENANTS IN MALIMGAS MARKET, MAKONG PHASE I, AND NEW GALVAN MARKET 1ST FLOOR VENDORS FOR TEN (10) DAYS BEGINNING MARCH 23, 2020 AND THE 2ND FLOOR VENDORS FOR ONE (1) MONTH FOR PERIOD APRIL 12, 2020.

WHEREAS, this body is in receipt of a letter dated March 23, 2020, from His Honor, the City Mayor, this city, requesting this body to enact draft ordinance granting rent holiday to tenants in Malimgas Market, Makong Phase I and New Galvan Market 1st floor vendors to be given rent holiday for 10 days beginning March 23, 2020 and the 2nd floor vendors to be given rent holiday for one month for period of April 12, 2020;

WHEREAS, finding said request to be one of the most cogent relief to its constituents, it being the fact that Corona Virus Disease-19 (COVID-19) continues to bring economy disaster to the business community;

NOW, THEREFORE, on motion of Councilor Michael B. Fernandez, duly and jointly seconded by Councilors Marcelino D. Fernandez, Luis M. Samson, Jr., Joshua Bon Bon F. Bugayong, be it enacted by the Sangguniang Panlungsod in its regular session assembled that:

SECTION 1. There is hereby granted rent holiday to tenants in Malingas Market, Makong Phase I, and New Galvan Market (1st floor vendors for ten (10) days beginning March 23, 2020 and the 2nd floor vendors for one (1) month for period April 12, 2020.

SECTION 2. This ordinance shall take effect upon approval.
