ORDINANCE NO. 2218-2020

AN ORDINANCE AMENDING ANEW SECTION 3 OF ORDINANCE NO. 2203-200, ENTITLED 'IMPOSING CITYWIDE CURFEW FROM 9:00 O'CLOCK P.M. TO 4:00 O'CLOCK A.M. DURING THE STATE OF PUBLIC HEALTH EMERGENCY' AND REPEALING ORDINANCE NO. 2206-2020.

WHEREAS, the Sangguniang Panlungsod passed Ordinance No. 2202-2020 which imposes city-wide curfew from 9:00 p.m. to 4:00 a.m. throughout the period of public health emergency as a means of protecting and promoting the health of the people by limiting the non-essential movement of people and preventing the local transmission of COVID-19;

WHEREAS, this august body amended the said Ordinance through the passage of Ordinance No. 2206-2020 and extended the curfew hours from 10:00 p.m. to 4:00 a.m.;

WHEREAS, there is a need to shorten anew the curfew hours during the community quarantine imposed under the subject Ordinance in order to allow longer hours and daily turnover of food establishments offering dine-in services as well as other business desiring to extend business hours as means of mitigating, if not reversing, the current economic downturn brought about by the public health emergency.

NOW, THEREFORE, on motion of Councilor Jose Netu M. Tamayo, duly seconded by Councilor Marcelino D. Fernandez, be it ordained by the Sangguniang Panlungsod in regular session assembled that:

SECTION 1. **COVERAGE.** Ordinance No. 2206-2020 is hereby repealed. Consequently, Ordinance No. 2203-2020, Section 3 thereof, is correspondingly amended to read as follows:

Curfew. A curfew from 11:00 in the evening (11:00 p.m.) to 4:00 in the morning 4:00 a.m. shall be imposed in the entire City of Dagupan, and shall be enforced throughout the period of the state of public health emergency, which will subsist until lifted by the President.

SECTION 2. **REPEALING CLAUSE.** Any previously issued ordinance, or provisions of ordinance, which is inconsistent herewith is hereby repealed accordingly.

SECTION 3. **EFFECTIVITY.** This Ordinance shall take effect after the requisite publication in a newspaper of general circulation.
