ORDINANCE NO. 2236-2021

AN ORDINANCE APPROVING THE INCREASE OF MONTHLY HONORARIUM FOR THE BARANGAY TANODS SERVING THE CITY OF DAGUPAN.

WHEREAS, it is the policy of the City of Dagupan to protect and promote the rights and welfare of barangay volunteer workers to enhance their capabilities to be effective as well as efficient partners in community development in addition to the furtherance of their privileges provided for by existing laws and local ordinances;

WHEREAS, while barangay personnel, particularly those tasked with implementing peace and security in the community, are given some benefits under the Local Government Code, such benefits are minimal and limited compared to the tasks they perform for the community;

WHEREAS, the barangays have limited budget, and the present honorarium of the barangay tanods, can hardly compensate for the service they render to the community;

WHEREAS, there is a need to increase the honorarium of the barangay tanods not only to augment the benefits they receive from the City Government, but also as a

manner of recognition of their efforts, support, assistance and contribution to barangay peacekeeping.

NOW, THEREFORE, on joint motion of Councilors Celia C. Lim, Maria Librada Fe M. Reyna, Cisco Jay P. Flores, Teresa T. Coquia, Jose Netu M. Tamayo, Michael B. Fernandez, duly and jointly seconded by Councilors Karlos Liberato E. Reyna IV, Luis M. Samson, Jr., Dennis C. Canto, Marvin V. Fabia, Marcelino D. Fernandez, and Joshua Bon Bon F. Bugayong, be it enacted by the Sangguniang Panlungsod of Dagupan in session assembled that:

SECTION 1. COVERAGE.

- a) This Ordinance granting an increase in the honorarium shall cover Barangay tanods, who are barangay-based peacekeeping volunteers working for the implementation of the peace and order programs of the different barangays of the City of Dagupan.
- b) As reference in the grant of the honorarium, and the corresponding increase provided in this Ordinance, the Punong Barangay shall submit a duly certified list of Barangay tanods, not exceeding twenty (20) in each barangay and in accordance with DILG Memorandum Circular 2003-42 and Section 391 and 392 of the Local Government Code.

SECTION 2. HONORARIUM INCREASE. A Five Hundred Pesos (Php500.00) increase in subsidy/honorarium is hereby granted to Barangay Tanod in the City's thirty-one (31) barangay

SECTION 3. APPROPRIATIONS.

- a) The funding source necessary for the implementation of this Ordinance shall be provided in the Annual or Supplemental Budget of the City Government of Dagupan.
- b) The amount herein required shall be charged against the FY 2021 appropriations. Such amount as may further be needed shall be given priority. The amount of P1,200.00 per barangay tanod shall be incorporated in the Annual Investment Plan (AIP) of the City of Dagupan , and shall be integrated in the yearly budgeting allocation.

SECTION 4. SEPARABILITY CLAUSE. If for any reason, any part or provision of this Ordinance shall be declared illegal or unconstitutional, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE. Any previously issued ordinance, or provision of ordinance, which is inconsistent herewith is hereby amended, repealed, or modified accordingly.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon its approval and fifteen (15) days after its publication in a newspaper with circulation within the City of Dagupan.
