ORDINANCE NO. 2237-2021

FURTHER EXTENDING THE DEADLINE OF RENEWAL OF TRICYCLE PERMITS FROM JUNE 30, 2021 TO JULY 31, 2021 IN THE CITY OF DAGUPAN.

WHEREAS, on April 20, 2021, the Sangguniang Panlungsod enacted Ordinance No. 2031-2021, "EXTE4NDING THE DEADLINE OF RENEWAL OF TRICYCLE PERMITS FROM THE ORIGINAL DEADLINE OF MARCH 31, 2021 IN THE CITY OF DAGUPAN.";

WHEREAS, this body is in receipt of a letter from His Honor, the City Mayor, requesting the passage of an ordinance imposing moratorium on and/or extending the deadline anew for renewal of tricycle permits under existing legislation, from the deadline of Jun3e 30, 2021 until July 31, 2021;

WHEREAS, the enactment of said enabling ordinance will alleviate the economic hardship being felt by tricycle drivers and operators in our city amid the travel and passenger-capacity restriction imposed by the national government as part of health and safety protocols during the public health emergency and in consideration of the fact that still some of the operators failed to meet the deadline imposed;

NOW, THEREFORE, on motion of Councilor Karlos Liberato E. Reyna IV, duly and jointly seconded by Councilor Dennis C. Canto, Maria Librada Fe M. Reyna, and Marcelino D. Fernandez, be it ordained by the Sangguniang Panlungsod in regular session assembled that:

Section 1. PURPOSE. The Ordinance aims to uplift the plight of business sector in view of the declared public health emergency.

Section 2. LIMITATION. The further renewal of tricycle permits is extended to July 31, 2021.

Section 3. SEPARABILITY CLAUSE. Any provision or portion of this Ordinance found to be contrary to the provisions of the Constitution or other existing laws shall not impair the provisions or parts thereof which shall continue to be in full force and effect.

Section 4. REPEALING CLAUSE. All Ordinances, rules and regulations in conflict with the provisions of this Ordinance shall not be impaired.

Section 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.
