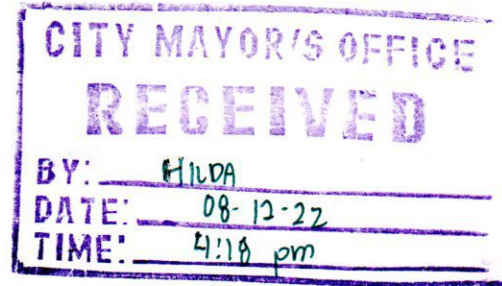

**ORDINANCE NO. 2249-2022**

**LIFTING THE IMPLEMENTATION OF ORDINANCE NO. 2204-2020, "REGULATING THE OPERATION OF PRIVATE VEHICLES WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF DAGUPAN DURING THE STATE OF PUBLIC HEALTH EMERGENCY BY IMPOSING A NUMBER CODING SCHEME."**

WHEREAS, on May 15, 2020, the city government of Dagupan enacted Ordinance No. 2204-2020, "REGULATING THE OPERATION OF PRIVATE VEHICLES WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF DAGUPAN DURING THE STATE OF PUBLIC HEALTH EMERGENCY BY IMPOSING A NUMBER CODING SCHEME;"

**WHEREAS**, such unified vehicular volume reduction program, commonly called number coding is a road space rationing program in the city to reduce traffic congestion, in particular during peak hours by restricting the private vehicles that can use major public roads due to the outbreak of the COVID-19 pandemic;

**WHEREAS**, the City of Dagupan has been placed under the most lenient COVID-19 Alert Level 1 status;

**WHEREAS**, as the city continues to move forward after the pandemic, more and more aspects of our "normal" life are slowly coming back to normal, wherein more people are able to go back to work and some schools are even beginning to facilitate face-to-face classes not to mention the fact that all sorts of establishments and facilities are now open to the public;


**WHEREAS**, such lifting is to provide unhampered mobility by allowing them to use their vehicles going to and fro in the city considering that the City of Dagupan is the center of trade, commerce and industry north of Manila;

**NOW, THEREFORE**, on motion of Councilor Alvin T. Coquia, duly and jointly seconded by Councilors Marilou Maria Lourdes S. Fernandez, Celia C. Lim, and Redford Christian P. Erfe-Mejia, be it ordained by the Sangguniang Panlungsod of Dagupan City in regular session duly assembled, that:

**Section 1.** The implementation of Ordinance No. 2204-2020 is hereby lifted.

**Section 2.** This Ordinance shall take effect immediately.
