ORDINANCE NO. 2252-2022

ALLOWING THE TEMPORARY CLOSURE OF GALVAN STREET (UP TO CORNER NUEVA STREET), JOVELLANOS EXTENSION, ZAMORA STREET (UP TO CORNER JOVELLANOS STREET) AND IN FRONT OF CITY MUSEUM ON NOVEMBER 25, 2022 TO JANUARY 30, 2023 IN CELEBRATION OF THE 'PASKO ED DAGUPAN' AND TO ENTER INTO CONTRACTS IN RELATION THERETO AS AN EFFECTIVE MEANS OF SPURRING ECONOMIC ACTIVITY AND ENLIVENING LOCAL TOURISM.

WHEREAS, the City of Dagupan acknowledges the worldwide observance of the festive and happy Christmas season in December of every year;

WHEREAS, the City also celebrates its fiesta on the same month annually;

WHEREAS, the validity of the city's trade and commerce even on the street level is an unmistakable affirmation of the position that the City of Dagupan holds in this part of the country;

WHEREAS, the observance of the Christmas season and the celebration of the "Pasko ed Dagupan" serve as a great opportunity to promote the ingenuity of Dagupan culture to foster unity and camaraderie among Dagupeños;

WHEREAS, the celebration of the "Pasko ed Dagupan", will hold various activities such as, but not limited to, trade fairs, food bazaars and flea markets or *baratillos* along the aforementioned streets;

WHEREAS, records show that one of the most effective and viable way of spurring economic activity in the central business district of the city is to allow the operation of a "baratillo" and food strip which since their inception continue to earn appreciation from the public;

WHEREAS, Section 21 paragraphs (a) and (c) of Republic Act No. 7160, otherwise known as the Local Government Code allows every local government, through appropriate legislation of its sanggunian, to temporary close any local and national road, especially for the purpose of agro-industrial fair, fiesta celebration, cultural and civic activities;

WHEREAS, Section 21 (d) of the same Code allows activities to be held in local streets, to wit:

"Any city, municipality, or barangay may, by a duly enacted ordinance, temporarily close and regulate the use of any local street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public."

WHEREAS, there is a need to allow the temporary closure of Galvan and Zamora Streets from November 25, 2022 to January 30, 2023, in celebration of the "Pasko ed Dagupan", and to enter into contracts in relation thereto as an effective means of spurring economic activity and enlivening local tourism;

NOW, THEREFORE, on motion of Councilor Marcelino D. Fernandez, duly and jointly seconded by Councilors Alvin T. Coquia and Alipio Serafin D. Fernandez, be it ordained by the Sangguniang Panlungsod in its regular session assembled that:

SECTION 1. AUTHORIZING THE BARATILLO AND/OR TRADE FAIR IN CELEBRATION OF THE "PASKO ED DAGUPAN". The City hereby authorizes the holding of baratillo and/or trade fair and food strip in celebration of the City Fiesta as well as "Pasko ed Dagupan".

SECTION 2. PURPOSE. The holding of food strip and baratillo and/or trade fair is for the purpose of spurring economic activity as well increase in the influx of visitors.

SECTION 3. TEMPORARY CLOSURE OF GALVAN STREET (UP TO CORNER NUEVA STREET), JOVELLANOS EXTENSION, ZAMORA STREET (UP TO CORNER JOVELLANOS STREET) AND IN FRONT OF CITY MUSEUM ON NOVEMBER 25, 2022 TO JANUARY 30, 2023 IN CELEBRATION OF THE 'PASKO ED DAGUPAN.'

SECTION 4. SANITATION AND CLEANLINESS:

1. Each stallholder shall maintain cleanliness within the assigned premises and its immediate surroundings by providing his/her business with own trash bag and hired cleaner.
2. For stallholders that sell food, they must allow inspection by the City's Sanitation Officers of the food, beverages and water to be served.

SECTION 5. ORDERLINESS:

1. Each stallholder in the conduct of his/her trade, must always observe courtesy and respect to fellow stallholder and customers.
2. Public information, safety, peace and order and consumer right protection and assistance desks shall be installed at both ends of the market area.


SECTION 6. SEPARABILITY CLAUSE. Any provision or portion of this Ordinance found to be in violation to the Constitution or other existing laws shall not impair the provisions or parts thereof which shall continue to be in full force and effect.


SECTION 7. REPEALING CLAUSE. All ordinances, rules and regulations in conflict with the provisions of this Ordinance are hereby repealed, provided that the rights that are vested upon the effectivity of this Ordinance shall not be impaired.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.
