ORDINANCE NO. 2326-2025

AN ORDINANCE AUTHORIZING THE CITY HEALTH OFFICE, DAGUPAN CITY, THE DISPOSITION OF PHILHEALTH ABTC (ANIMAL BITE TREATMENT CENTER) PACKAGE AMOUNTING TO THREE THOUSAND NINE HUNDRED PESOS (PHP3,900.00).

WHEREAS, Rabies is a fatal disease in developing countries where animal immunization and control of dogs are inadequate. In view of the 100% case fatality of human rabies, the prevention of rabies infection after exposure is of utmost importance;

WHEREAS, to ensure an effective and efficient management for eventual reduction, if not elimination of human rabies, and to increase voluntary pre-exposure coverage among high-risk groups and post-exposure patient through FREE rabies immunization for PHIC indigent patients;

NOW, THEREFORE, on joint motion of Councilors Jalice D. Cayabyab and Jose Netu M. Tamayo, duly and jointly seconded by Councilors Karlos Liberato E. Reyna IV, Marvin DV. Fabia, Bradley Claude C. Benavides, Marcelino DS. Fernandez, Christel Hilary U. Paras, and Danielle Francine B. Canto, be it ordained by the Sangguniang Panlungsod in regular session assembled that:

SECTION 1. TITLE. -This Ordinance shall be known as "AN ORDINANCE AUTHORIZING THE CITY HEALTH OFFICE, DAGUPAN CITY THE DISPOSITION OF THE PHILHEALTH ABC (ANIMAL BITE TREATMENT CENTER) PACKAGE AMOUNTING TO THREE THOUSAND NINE HUNDRED PESOS (Php3,900.00)."

SECTION 2. - DISPOSITION OF PHIC ABC PACKAGE. There is hereby a disposition of the PHIC ABTC package allowed, to wit:

- 1. LGU Vaccine, Medicine, and Supplies (80%) -----P3,120.00
- 2. Professional Fees (20%)-----P 780.00
 - 2.1 Physician (40%)-----P312.00
 - 2.2 Healthcare Workers and Support Staff (60%)-----P468.00
 - 2.2.1 Animal Bite Staff (25%)-----P195.00
 - 2.2.2 Health Worker Staff (30%)-----P234.00
 - 2.2.3 Support Staff (5%)-----P 39.00

Section 3. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision hereof shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. REPEALING CLAUSE. All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, superseded and repealed accordingly.

Section 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.
